Annual Municipal Recycling Goals for the 2023-24 Fiscal year

- J. Baum reviewed the Municipal Recycling, Waste Reduction and Reuse Self-Evaluation Checklist. The municipal recycling coordinators should utilize the checklist to formulate municipal recycling goals for the 2023-24 fiscal year.

- A. Miles shared the municipal recycling goals for the Town of Newtown which include:
 - Constructing a solar powered aerated static pile (ASP) compost site.
 - Implementing a unit-based pricing program.
 - Increase presence at the transfer station for recycling education and program awareness.
- T. Carlson outlined municipal recycling goals set for the Town of Ridgefield detailed in the attachment.
- P. Silva reviewed the municipal recycling goals for the Town of Redding, including:
 - Collecting fire extinguishers at the Redding transfer station.
 - Improving signage on the containers at the transfer station.
 - Increase participation and awareness of the food scraps recycling program by creating signage with QR Codes to sign-up.
 - \circ $\;$ Research a new point of sale system for the transfer station.

Municipal Recycling Program Updates from recycling Coordinator/Representative

- T. Carlson announced that two schools in the Town of Ridgefield implemented Food scraps recycling programs and hauled 600 pounds of food scraps in one week.
- P. Silva stated the Town of Redding held a successful Shred and E-waste event.
